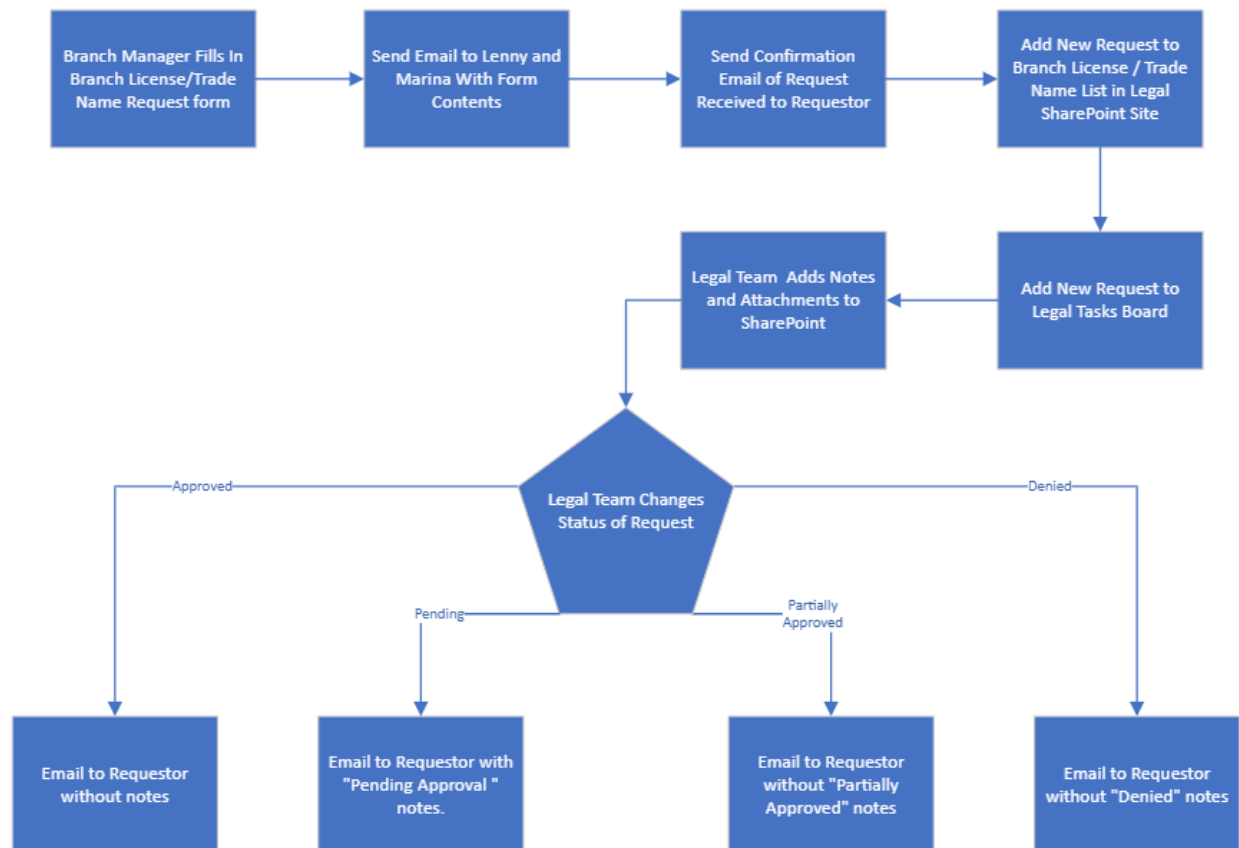

6 Manual Processes

6.1 Managing the Status of Requests and Notes

Members of the legal team will manually edit the status field in the [Branch License / Trade Name Requests SharePoint list](#). Status types will be as follows:

- New (default selection upon submission)
- Pending
- Partially Approved
- Approved
- Denied

NOTE: The reason for “Partially Approved” is that the Branch Email could have requested licenses in more than one state. In the case where some were approved and somewhere not, the legal team should add denial notes.

6.1.1 Pending, Partially Approved, Approved and Denied Notes

- Whatever is entered in the “Pending Notes” will be sent to the requestor when the status of the item is changed to “Pending”
- Whatever is entered in the “Partially Approved Notes” will be sent to the requestor when the status of the item is changed to “Partially Approved”
- Whatever is entered in the “Approved Notes” will be sent to the requestor when the status of the item is changed to “Approved”
- Whatever is entered in the “Denied Notes” will be sent to the requestor when the status of the item is changed to “Denied”

The “Attachments” field of the [Branch License / Trade Name Requests SharePoint list](#) may be used to attach any relevant documents. Anyone with access to the Legal SharePoint site may view these attachments. Branch emails do NOT have access to this site.

What it does:

- Sends “[New Branch License / Trade Name Request to Requestor](#)” email to requestor.
- Sends “[New Branch License / Trade Name Request to Legal Team](#)” email to legal team.
- [Creates a notification](#) in the MS Team “[Legal](#)” Channel
- Adds a task to the “[Legal task board](#)”
- Adds request to [SharePoint List](#)
- Adds link to Legal Task Board task in the Sharepoint list.
