

RACI MATRIX - INSTRUCTIONS

What is RACI?

RACI is a responsibility assignment matrix that clarifies roles for each project deliverable:

R - RESPONSIBLE (Doer)	The person(s) who do the actual work. Multiple people can be Responsible.
A - ACCOUNTABLE (Owner)	The ONE person ultimately answerable for the deliverable. Only ONE 'A' per row.
C - CONSULTED (Expert)	People whose input is required before decisions. Two-way communication.
I - INFORMED (Stakeholder)	People who need to know about progress. One-way communication.

How to Use This Template:

1. Go to the 'RACI Matrix' tab
2. Customize the roles (column headers) to match your team
3. Customize the deliverables (rows) to match your project
4. Fill in R, A, C, or I in each cell
5. Ensure each row has exactly ONE 'A' (Accountable person)
6. Ensure each row has at least one 'R' (Responsible person)
7. Keep 'C' and 'I' assignments minimal to avoid overhead
8. Review with your team and update as the project evolves

RACI LEGEND & BEST PRACTICES

RACI Color Coding:

- R** Responsible - Does the work
- A** Accountable - Owns outcome (ONE per deliverable)
- C** Consulted - Provides input before completion
- I** Informed - Kept updated on progress

Key Rules:

- ✓ Each deliverable must have exactly ONE 'A' (Accountable)
- ✓ Each deliverable must have at least one 'R' (Responsible)
- ✓ Keep 'C' minimal (2-3 max) to avoid slow progress
- ✓ Keep 'I' minimal - only those who truly need updates
- ✓ Update when team members change or scope shifts
